## **Guru Nanak Dev University**

Guru Nanak Dev University was established on November 24, 1969 to mark the birth Quincentenary of Sri Guru Nanak Dev Ji, the founder of Sikhism. The University upholds the teachings and values of the Guru, the apostle of universal brotherhood, truthfulness, non-violence, compassion, tolerance, harmony, humanity, who strictly observed moral and ethical values in daily life.

Ever since its foundation the endeavour of the University has always been to meet the objectives enshrined in the Guru Nanak Dev University Act 1969, which emphasize that the new University would make provisions for imparting education and promoting research in the humanities, learned professions, sciences, especially of applied nature and technology. Hence, it has been promoting education in such fields as Basic and Applied Sciences, Arts, Management, Information Technology, Media, Industrial Technology, Environment, Planning and Architecture Studies. In addition, research on the life and teachings of Guru Nanak Dev ji, promotion of Punjabi language and spreading education among educationally backward classes and communities are its other commitments.

The UGC conferred this University with status of “University with Potential for Excellence” in 2012. The National Assessment and Accreditation Council (NAAC), Bangalore in December 2022 re-accredited the University in 4<sup>th</sup> cycle with **CGPA of 3.85 out of 4-pointscale at “A++” grade** highest level, as per accreditation framework of NAAC. Earlier, it had been accredited at “A” grade level in 2000, re-accredited in 2<sup>nd</sup> cycle 2007 with CGPA of 3.50/4.00 then re-accredited in 3<sup>rd</sup> cycle in 2014 with CGPA 3.51/4.00. The current H index of the university is 144 indicating the quality of research publications at national and international level.

Guru Nanak Dev University, Amritsar has become the only University of Punjab to get the elite "Category-1" status by the University Grants Commission (UGC), giving autonomy to open new Departments, schools, off-campus facilities and starts new schools and distance learning programmes, besides the freedom to hire foreign faculty without the UGC's approval.

With the motto of the University as engraved on its emblem ‘Guru's wisdom illumines all’, the University has been leaving no stone unturned to meet the aspirations and expectations of the society. Spread over area of 500 acres towards the west of the city, Guru Nanak Dev University presents a picture of lush green landscape, modern architecture and sustainable environment. The University today boasts of 45 teaching Departments at the Campus, two regional campuses and 170 affiliated, university and constituent colleges, many of which are located in the rural areas so as to make quality Higher Education accessible to the rural masses. All the programmes of the university compile the guidelines of New Education Policy 2020.

More than twenty thousand students, an overwhelming majority of them being women, are enrolled in various Departments at University Campus, Regional Campuses and University-Constituent Colleges. Online admission, online Counselling, online re-evaluation, introduction of Credit Based Evaluation & Grading System etc. are a few hallmarks of the University. All the results have been computerized and OMR (Optical Magnetic Recognition) system is being used to bring in more efficiency and transparency. It is the first University in the region to have computerized its examination and registration system. The students now have an all-time access to their results through SMS service.

Academically also, the University has carved a niche for itself in the field of Higher Education in the country. Our university is recognized as one of the leading institutions in North India in the domain of Arts, Humanities, Science and Technology. Many coveted projects from the apex bodies like MHRD, DST, CSIR, BARC and other organizations worth crores of rupees have been awarded to our faculty members. One of the four Nodal Calibration Centres established by Bhabha Atomic Research Centre is set up at our campus. The Centre of Emerging Life Sciences equipped with the state-of-the-art scientific instrument's worth crores of rupees, a well-maintained Botanical Garden, Department of Sports Medicine & Physiotherapy are a few to mention. A well-equipped modern computer lab with the help of TCS has been established to strengthen the University infrastructure and to prepare students for employment. Presently, a Centre with Potential for Excellence in Life Sciences and a Centre for Advanced Study in Chemistry granted by UGC are

working successfully in the University. A Centre for Entrepreneurship and Innovation is being set up in the university under the aegis of *Rashtriya Uchatar Shiksha Abhiyan* to provide skill-oriented training and incubation facilities.

The fact that the University has been the winner of the coveted Maulana Abdul Kalam Azad Trophy, the highest Sports award for a University in the country, for a record number of 25 times, speaks volumes about its supremacy in the field of Sports. An Astro Turf for hockey, a swimming pool of International Standards, a velodrome, a gymnasium hall, a shooting range and many other state-of-the art Sports facilities are the prized possessions of the University. The Lifelong Learning Department of the University is successfully catering to the male and female folk of the region to make them self-dependent by offering various skill development programmes.

The track record of employment of our students by big business houses and multinational companies has been very satisfactory. Our students of engineering, planning, architecture, management and commerce field are employed by government sector and companies in India and abroad. They are all contributing to the credit worthiness of the University by their hard work and diligence. All these achievements and successes are due to the heart and soul put in by the students, faculty members, and administration of the University.

1. The Candidates seeking admission to B.A. LL.B. (Hons) Five Years/ B.A. LL.B Five Years/ LL.B Three Years/B.Com. LL.B. Five Years/ B.Com. LL.B. (Hons) Five Years and B.B.A. LL.B Five Years Courses in the Departments/Colleges/Regional Centres of Sri Guru Teg Bahadur State University of Law, Tarntaran, Guru Nanak Dev University, Amritsar, Punjabi University, Patiala and the Colleges affiliated to Guru Nanak Dev University, Amritsar, Punjab University, Chandigarh and Punjabi University, Patiala and situated in the State of Punjab shall submit online application for centralized counselling. 2. 85 % seats would be reserved for the candidates from within the State as per the eligibility criteria of the Government of Punjab and 15 % will be open to candidates of other States/UTs on All India basis.  
**Reservation is as per Punjab State Government policy. All the candidates must declare their claims for reserved category at the time of filling the online application forms carefully for the counselling. Subsequent claims or change shall not be accepted after the form has been submitted.**
3. **In case the candidate fails to produce the certificate of the reserved category, for which he/she is claiming the seat, from competent authority (as given in the reservation policy) at the time of counselling, the candidate will not be admitted.**



## **B) ONLINE SUBMISSION OF APPLICATION FORM**

1. The application form shall be submitted by the candidates online at

2. Each candidate can deposit counselling fee through online mode Netbanking/ Credit/ Debit card or through HDFC Bank Pay-In-Slip in any branch as per the details below:
  - (i) Scheduled Castes and Scheduled Tribes Candidates: **Rs. 1000/- each.**
  - (ii) Other Candidates (Other than SC/ST): **Rs. 2000/- each.**
3. No application form submitted by post/by hand will be accepted and the candidature of such candidates for centralized counselling will stand automatically rejected. Such candidates will have no claim whatsoever.
4. The candidates shall fill up online application form very carefully. They are required to fill up all the applicable columns with utmost care. They are advised to remember their **User Id and Password** as the same may be needed at the time of counselling.

## **C) EDUCATIONAL QUALIFICATIONS**

1. The candidates are advised to check their eligibility and read the eligibility requirements, general conditions etc. as provided in the notification issued by the Government of Punjab (vide no. **HED-EDU10NOTC/1/2020-3Edu.1/801837/2024 Dated 13/03/2024**) and appended herewith. Every candidate claiming reserved category must indicate the reserved category claimed.
2. **The candidates are advised to check the eligibility norms of the Bar Council of India and those prescribed by the respective Universities very carefully before applying for admission and take a well considered and informed decision as to law course/courses they intend to pursue. The candidates shall be solely responsible for their choice.**
3. The eligibility norms as prescribed by the Bar Council of India and the educational qualifications as prescribed by the respective Universities for B.A. LL.B. (Hons) Five Years/B.A. LL.B. Five Years/LL.B. Three Years/B.Com. LL.B. Five Years, B.Com. LL.B. (Hons) Five Years and B.B.A. LL.B. Five Years Courses are as under:

### **BAR COUNCIL OF INDIA:**

#### **Eligibility for Admission:-**

Eligibility for admission shall be as per the regulation of Bar Council of India.  
(Annexure-A)

- (a) **Three Year Law Degree Course:** An applicant who has graduated in any discipline of knowledge from a University established by an Act of Parliament or by a State legislature or an equivalent national institution recognized as a Deemed to be University or foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for a three years' degree program in law leading to conferment of LL.B. degree on successful completion of the regular program conducted by a University whose degree in law is recognized by the Bar Council of India for the purpose of enrolment.
- (b) **Integrated Degree Program:** An applicant who has successfully completed Senior Secondary School course ('+2') or equivalent (such as 11+1, 'A' level in Senior School Leaving certificate course) from a recognized University of India or outside or from a



Senior Secondary Board or equivalent, constituted or recognized by the Union or by a State Government or from any equivalent institution from a foreign country recognized by the government of that country for the purpose of issue of qualifying certificate on successful completion of the course, may apply for and be admitted into the program of the Centres of Legal Education to obtain the integrated degree in law with a degree in any other subject as the first degree from the University whose such a degree in law is recognized by the Bar Council of India for the purpose of enrolment.

Provided that applicants who have obtained + 2 Higher Secondary Pass Certificate or First Degree Certificate after pursuing studies in distance or correspondence method shall also be considered as eligible for admission in the Integrated Five Years Course or three years' LL.B. course, as the case may be.

**Explanation:** The applicants who have obtained 10 + 2 or graduation/post graduation through open Universities system directly without having any basic qualification for pursuing such studies are not eligible for admission in the law courses.

### **Prohibition to register for two regular courses of study**

No student shall be allowed to simultaneously register for a law degree program with any other graduate or postgraduate or certificate course run by the same or any other University or an Institute for academic or professional learning excepting in the integrated degree program of the same institution.

Provided that any short period part time certificate course on language, computer science or computer application of an Institute or any course run by a Centre for Distance Learning of a University, however, shall be excepted.

### **Minimum marks in qualifying examination for admission**

Bar Council of India may from time to time, stipulate the minimum percentage of marks not below 45% of the total marks in case of general category applicants and 40% of the total marks in case of SC and ST applicants, to be obtained for the qualifying examination, such as +2 Examination in case of Integrated Five Years' Course or Degree Course in any discipline for Three years' LL.B. course, for the purpose of applying for and getting admitted into a Law Degree Program of any recognized University in either of the streams.

Provided that such a minimum qualifying marks shall not automatically entitle a person to get admission into an institution but only shall entitle the person concerned to fulfill other institutional criteria notified by the institution concerned or by the government concerned from time to time to apply for admission.

### **DIVISION OF SEATS**

- a. 85% of the seats will be reserved for the candidates from within the State of Punjab and 15% seats will be open to candidates of other States/U.Ts, on the basis of merit. The eligibility criteria for 85% seats will be that the candidate must be a resident of Punjab State in terms of Punjab Government, Department of Personnel and Administrative Reforms (PP-II Br) letter No. 1/3/95-3PP-II/96 19, dated 6<sup>th</sup> June, 1996 and letter No. 1/3/95-3PP-11/80 date 1st January, 1999. The notifications are annexed at Annexure B and C respectively.
- b. If sufficient number of candidates belonging to reserved category (i.e.) is not available, the vacant seats will be offered to candidates in open category. Likewise, if seats under 15% categories remain vacant, these would be transferred to 85% category and vice-versa. Further if suitable candidates are not available in any one of the sub-categories of reserved categories, the seats so available will be filled up by the candidates from the other sub categories and if they are not available in any sub-category, then seats shall be filled up from general/open category candidates.
- c. The admission to NRI seats shall be as per direction of the Hon'ble Supreme Court.
- d. Supernumerary seats exclusively for the Kashmiri migrant students who are temporarily residing in the Punjab State will be created for the year 2012-13, in terms of Letter D.O. No. F.10-1/2002 Destk (U) dated 13.03.2003 of the Ministry of Human Resource Development, Government of India, New Delhi subject to condition that they will have to submit proof of their being Kashmiri migrant, and further:
  - i. Increase in intake capacity upto 5%
  - ii. Reservation of at least one seat in merit quota in the institution: and
  - iii. Waiving of domicile (residence) requirement.

### **D) RESERVATION OF SEATS**

The Governor of Punjab is pleased to issue the Reservation Policy & Common Weightage Policy for Admission in Govt. Colleges and Govt. Aided Colleges (including Self-Financing Courses in that Colleges) of the State of Punjab under Higher Education Department in the Reservation Policy & Common Weightage Policy shall be as under :-

This Notification shall come into force with immediate effect.

A. Reservation Policy for Admission in Govt. Colleges and Govt. Aided Colleges (including Self-Financing Courses in that Colleges) of the State of Punjab is as under:-

1. The Inter-se priority for reservation to the wards of Armed Forces personnel for admission in education institutions will be as provided by the letter no. 6(1)/2017D (Res.II) dated 21.05.2018.
2. In case of persons with disability seeking admission in educational institutions there will be a relaxation of 5 years in the upper age limit where ever applicable.



3. All the Govt. Colleges and Govt. Aided Colleges (including Self-Financing Courses in that Colleges) affiliated with 3 State Universities and located within Punjab i.e. GNDU Amritsar, Punjabi University Patiala, Panjab University, Chandigarh will come under the purview of Common State reservation policy, Punjab. i.e. State Reservation policy will be applicable to all type of colleges for admissions in UG and PG Courses.
4. 3% reservation is for the PWD only and it will not be further bifurcated into General, SC and BC. i.e. an eligible PWD candidate (as per State disability norms) will be allotted the seat on the basis of the merit irrespective of its Category (Gen, SC or BC)
  - a. In the event of quota reserved for suitable category of Handicapped Candidates remains unutilized (i.e. 1% for Blindness or low vision, 1% hearing impairment & 1% for locomotor disability or cerebral palsy), the unutilized seats benefit may be given to other suitable categories of PWD on merit basis i.e. seat share for blindness will be transferred to hearing or locomotor disability and vice versa.
  - b. In the event of quota reserved (3%) for Physically Handicapped remain unutilized, the conversion of seats may be done from PWD to General at the time of physical counseling. (i.e. vacant seats will be filled up on merit basis by the colleges)
5. Further, 13% reservation is provided to Ex-servicemen and their dependants by providing reservation within reservation of:
  - 7% to General Category Ex-Serviceman,
  - 4% to Scheduled Caste Ex-Serviceman and
  - 2% to Backward Class Ex-Serviceman

**This Horizontal reservation is applicable for admission to the various educational institutions of the Govt. Colleges and Govt. Aided Colleges (including Self-Financing Courses in that Colleges) located in Punjab.**

- a. As per instructions of Department of Social Justice, Empowerment & Minorities vide letter dated 22-10-2009, if Ex serviceman is not available from SC category, then the seats will be filled from amongst SC (General) Category only.
  - b. As per instructions of Department of Social Justice, Empowerment & Minorities vide letter dated 03-01-2017, if Ex-serviceman is not available in Backward Category, then the seats will be filled from amongst Backward Category (General) only.
  - c. Further, if the seats still remain vacant which are reserved for Ex-Serviceman, the conversion of seats may be done from Ex-servicemen to General at the time of physical counseling. (i.e. vacant seats will be filled up on merit basis by the colleges)
6. Further, 3% reservation is provided to Sports category candidates which is further bifurcated horizontally into 2% reservation for Sports General and 1% for Sports SC.

- a. As per instructions of Department of Social Justice, Empowerment & Minorities vide letter dated 22-10-2009, if Sports person is not available in SC category, then the seats will be filled from amongst SC Category (General) only.
  - b. However,
    - i. in the event of quota (2%) for General Category in the Sports Category remains unutilized, then the conversion of seats may be done from Sports Category(2%) to General Category at the time of physical counseling.
    - ii. in the event of quota (1%) for SC Category in the Sports Category remains unutilized, then the conversion of seats may be done from Sports SC Category(1%) to General SC Category at the time of physical counseling.
7. Further, 1% reservation is provided to wards of Freedom fighters
- a. However, in the event of quota reserved (1%) for Freedom fighters category remains unutilized, the conversion of seats may be done from Freedom fighters category to General at the time of physical counseling. (i.e. vacant seats will be filled up on merit basis by the colleges)
8. While working out the percentage of seats in the Reserved Categories as per State reservation policy, if the number arrived at, contains a fraction, this shall be resolved as follows :-
- a. If the fraction is 0.5 or more, it shall be rounded off to 1; if it is less than 0.5, it shall be ignored. *For instance: 2.4 seats would rounded off to 2; similarly 2.6 would be rounded off to 3*
  - b. After rounding up or down -if the total number of seats after making this adjustment exceeds the prescribed number fixed for the course, the necessary additional seats shall be created and considered as part of the total number of sanctioned seats. This shall, however, not affect the total number of seats in the General Category.
9. A roster register for reservation of seats for ex-servicemen/PWD/FF shall be maintained and carry forward all fractions through different fractions over the years till the accumulation of fraction is 0.5 or greater. As and when the total sum value of fractions exceeds to 0.5 or greater, a seat will be provided in that particular category. The carry forward, accumulation and rounding off cycle will go on and on.

- I. Graduation Certificate issued by the Director, Department of Sports, Punjab is compulsory.
- II. The candidate must be eligible to participate in the Inter University Competitions for which eligibility is as under :
  1. Must not be more than 28 years of age on July 1<sup>st</sup> of the year of admission;

**E) Weightage In The Merit For Rural Area Candidates:**

While calculating merit, credit of 1% maximum marks will be given to candidates seeking admission under 85% category, who have passed their 10<sup>th</sup> and 12<sup>th</sup> class examination from schools situated in the rural areas of Punjab. For this, they will have to submit a certificate issued by the Head/Principal of the school stating that the student has passed 10<sup>th</sup> and 12<sup>th</sup> class from his school and that the school falls in the rural area. The certificate should be counter signed by the Sarpanch of the Village.

**Note: In case the rural area certificate is not as per rules, the institution/college will not admit the candidate and subsequently direct the candidate to correct his/her rural area benefit through counselling university to appear in the next round of counselling as per schedule.**

**F) SHIFTING OF SEATS:**

There shall be three counselling for admission. The shifting of seats will be allowed as per the following:

Candidate who has got the seat according to his/her 1st preference in any round of counselling he/she will not be part of next round of counselling. Any such candidates, if interested to participate in next round of counselling has to pay Rs 1000/- (Rs 500/- for SC/ST Candidates). In that case he/she will not have any claim to the previous allocated seat. All other candidates will be automatically the part of the next round of counselling and can change their preferences without payment of any fees. If any candidate, who is allocated 1<sup>st</sup> preference College/ Institute in the first and second round of counselling, will not be considered for the third round of counselling.

**G) GENERAL CONDITIONS:**

1. The eligibility of the candidate and his/her original documents will be checked by the institution in which the candidate is allocated seat at the time of admission. Thus, allocation of seat does not entitle automatically the candidate to get admission to the course. This will be subject to checking of his/her original documents and his/her eligibility at the institution level in which he/she is allocated the seat.
2. The candidate will be solely responsible for wrong supply of information on-line or otherwise. He/She should check his/her eligibility carefully and should supply all the information correctly; else his/her application form for allocation of seat will stand automatically rejected. Also, incomplete application forms will be rejected.
3. Candidates applying for the reserved category shall carefully indicate the claim for only one category in the online admission form to be submitted to the University in the first instance before the start of counselling. No change of category will be entertained / permitted at the later stage in the application form.
4. The candidate must read the notification very carefully and he/she shall be solely responsible for any lapses.

5. In case a student shifts from one institution to the other during second/third Centralized Counselling his/her fee shall be refunded by the previous institution after deduction of Rs. 1000/- (Rupees one thousand only) as the processing fee.
6. Candidates will be admitted in the respective institutions on the basis of the seats that will be allocated through centralized counselling by the University. There will be no Entrance Test.

#### **H) NORMALIZATION OF MARKS**

1. The qualifying marks obtained by each candidate will be normalized using a set formula. After normalization of marks for each university of the Punjab State, a combined merit list will be prepared. Normalization of marks will not be applicable to the candidates taking admission under the all India quota.
2. While calculating merit, credit of 1% maximum marks will be given to candidates seeking admission under 85% category, who have passed their 10<sup>th</sup> and 12<sup>th</sup> class examination from schools situated in the rural areas of Punjab. For this, they will have to submit a certificate issued by the Head/Principal of the school stating that the student has passed 10<sup>th</sup> and 12<sup>th</sup> class from his school and that the school falls in the rural area. The certificate should be counter signed by the Sarpanch of the Village.
3. The following normalization procedure will be adopted for determining the merit of the candidates for allocation of seats for admission in the affiliated colleges/institutions.

**Note: If a candidate has passed qualifying examination in a year before 2024, the marks obtained by the topper of 2024 will be taken for normalization.**

#### **For Five-Year B.A., LL.B./B.A., LL.B. (Hons)/B.Com., LL.B./B.Com., LL.B. (Hons)/B.B.A.LL.B.:**

Normalization of marks will be done on the basis of marks obtained by a candidate in Senior Secondary (+2) examination conducted by C.B.S.E., I.S.C.E., and P.S.E.B. in the state of Punjab. There will be no normalization of marks for students from other States or Boards.

For normalization of marks for centralized counselling for admission to five-year B.A., LL.B./ B.A., LL.B. (Hons)/ B.Com., LL.B./ B.Com., LL.B. (Hons)/ B.B.A., LL.B. Courses, the stream of the candidate who passed class XII examination from the CBSE/ISCE/PSEB as the case may be will be determined as below:

#### **(i) Central Board of Secondary Education (CBSE):**

Total marks secured by the candidate in five subjects including English Core (out of Maximum of 500 Marks) in Medical/ Non-Medical/ Commerce/ Humanities stream.

#### **(ii) Council for the Indian School Certificate Examinations (ISCE):**

Total marks secured in four subjects, i.e., English and three other subjects with the highest marks (out of Maximum of 400 Marks). Streams: Medical/ Non- Medical/ Commerce/ Humanities.



**(iii) Punjab School Education Board (PSEB):**

Total marks secured by the candidate in Humanities/ Science/ Commerce/ Vocational stream (out of Maximum Marks).

**For Three Years LL.B. Course:**

Normalization of marks will be done on the basis of marks obtained by the candidate in the qualifying examination for students graduating from universities in the state of Punjab who are candidates for the Punjab quota seats. There will be no normalization of marks for students graduating from other state universities or Institutes.

**Normalization of marks in case of both B.A. LL.B. (Hons) Five Years/B.A. LL.B Five Years/ LL.B Three Years/B.Com. LL.B. Five Years and B.Com. LL.B. (Hons) Five Years/ B.B.A.LL.B. Five Years courses will be carried out as follows:**

$$\text{Normalized marks} = \frac{\text{Marks obtained by the candidate} \times 100}{\text{Marks obtained by the topper in the qualifying examination in the stream in which the candidate qualified}}$$

4. When two or more candidates have secured equal marks in the combined on line counselling, their inter-se merit for admission will be decided on the following criteria in the order of performance: -
  - i) Candidate with higher percentage of marks in Master's degree.
  - ii) Candidate with higher percentage of marks in the qualifying examination:
  - iii) Candidate older in age.

**I) ARMY INSTITUTE OF LAW:**

1. As per the Punjab Govt. notification No. HED-EDU10NOTC/1/2020-3edu/1/840927/2024 dated 14.05.2024 the revised allocation of seats for Army Institute of Law, Mohali is as below (refer Page No. 58 & 59 of prospectus):  
*"Out of 100 seats of B.A.LL.B. (5 Years) in Army Institute of Law, Mohali, 20 seats of Punjab Residents of Civil Category will be filled up through centralized online counselling by the Guru Nanak Dev University, Amritsar. There will be no Entrance Test for these seats. The remaining 75 seats (71 for wards of Army Personnel, 01 seat for ward of Indian Navy and 03 for wards of Indian Air Force) and 05 seats of All India General Category will be filled up by Army Institute of Law, Mohali by conducting the Online written test."*
2. The reservation policy of the Punjab Government shall not be applicable to 20 seats of Punjab Residents of Civil Category.

**J) MANAGEMENT QUOTA SEATS:**

1. 15% of the seats out of 85% state quota seats in un-aided Private Self-Financing institutions shall be treated as management quota and shall be brought out of the

purview of centralized counselling to be conducted by the University.

2. The management of the institute shall fill up management quota seats as per the procedure prescribed in the said notification.
3. The management quota seats will be filled up only after the third counselling is over as per the notified schedule.

**In case of any dispute, the decision of the Guru Nanak Dev University, Amritsar shall be final.**

**Note: No admission (including management quota seats) will be made without registering on the State level counselling portal by the candidate for the purpose of monitoring transparency in the admission process.**

Provided that admission to such a course of study for a degree in law is obtained from a University whose degree in law is recognized by the Bar Council of India for the purpose of enrolment.

- (b) A double degree integrated course combining Bachelors' Degree course as designed by the University concerned in any discipline of study together with the Bachelors' degree course in law, which shall be of not less than five years' duration leading to the integrated degree in the respective discipline of knowledge and Law together.

Provided that such an integrated degree program in law of the University is recognized by the Bar Council of India for the purpose of enrolment.

Provided further that in the case of integrated double degree course the entire double degree course can be completed in one year less than the total time for regularly completing the two courses one after the other in regular and immediate succession, meaning thereby, that if the degree course in the basic discipline, such as in Arts, Science, Social Science, Commerce, Management, Fine Arts, Engineering, Technology or medicine etc. is of three years' duration of studies, integrated course in law with the basic degree in the discipline could be completed in five years' time but where the degree course in basic discipline takes four or five years, the integrated degree in law with such degree course in the discipline would take one year less for completing in regular time than the total time taken for the two degrees taken separately if completed back to back.

**Explanation 1:** Double degree integrated course such as BA., LL.B. can be completed within (3+3 -1) i.e. 5 years. But if one intends to do B.Tech., LL.B. it can be done in (4+3-1) i.e., 6 years.

**Explanation 2:** Suppose in a University one can have a two years' graduation in any social science leading to BA degree, in that case also the composite double degree integrated course leading to BA, LL.B. would be of five years duration because double degree integrated course cannot be of less than five years' duration.

#### 5. Eligibility for admission:

(a) **Three Year Law Degree Course:** An applicant who has graduated in any discipline of knowledge from a University established by an Act of Parliament or by a State legislature or an equivalent national institution recognized as a Deemed to be University or foreign University recognized as equivalent to the status of an Indian University by an authority competent to declare equivalence, may apply for a three years' degree program in law leading to conferment of LL.B. degree on successful completion of the regular program conducted by a University whose degree in law is recognized by the Bar Council of India for the purpose of enrolment.

(b) **Integrated Degree Program:** An applicant who has successfully completed Senior Secondary School course ('+2') or equivalent (such as 11+1, 'A' level in Senior School Leaving certificate course) from a recognized University of India or outside or from a Senior Secondary Board or equivalent, constituted or

recognized by the Union or by a State Government or from any equivalent institution from a foreign country recognized by the government of that country for the purpose of issue of qualifying certificate on successful completion of the course, may apply for and be admitted into the program of the Centres of Legal Education to obtain the integrated degree in law with a degree in any other subject as the first degree from the University whose such a degree in law is recognized by the Bar Council of India for the purpose of enrolment.

Provided that applicants who have obtained + 2 Higher Secondary Pass Certificate or First Degree Certificate after prosecuting studies in distance or correspondence method shall also be considered as eligible for admission in the Integrated Five Years course or three years' LL.B. course, as the case may be.

**Explanation:** The applicants who have obtained 10 + 2 or graduation / post graduation through open Universities system directly without having any basic qualification for prosecuting such studies are not eligible for admission in the law courses.

#### **6. Prohibition to register for two regular courses of study**

No student shall be allowed to simultaneously register for a law degree program with any other graduate or postgraduate or certificate course run by the same or any other University or an Institute for academic or professional learning excepting in the integrated degree program of the same institution.

Provided that any short period part time certificate course on language, computer science or computer application of an Institute or any course run by a Centre for Distance Learning of a University however, shall be excepted.

#### **7. Minimum marks in qualifying examination for admission**

Bar Council of India may from time to time, stipulate the minimum percentage of marks not below 45% of the total marks in case of general category applicants and 40% of the total marks in case of SC and ST applicants, to be obtained for the qualifying examination, such as +2 Examination in case of Integrated Five Years' course or Degree course in any discipline for Three years' LL.B. course, for the purpose of applying for and getting admitted into a Law Degree Program of any recognized University in either of the streams.

Provided that such a minimum qualifying marks shall not automatically entitle a person to get admission into an institution but only shall entitle the person concerned to fulfill other institutional criteria notified by the institution concerned or by the government concerned from time to time to apply for admission.

#### **8. Standard of courses**

Whereas all Universities and its constituent and affiliated Centres of Legal Education conducting either the three year law degree program or the integrated double degree program for not less than five years of study or both would follow the outline of the minimum number of law courses both theoretical and practical,



Consequently, the appeal is allowed and the impugned judgement of the High Court is set aside.

I am directed to invite your attention to the Punjab Government Circular letter No. 1/3/95-3PPH/2043, dated 29-1-1996 vide which the instructions were issued regarding simplification of procedure for obtaining the certificate of domicile for the purposes of admission to educational institutions (including technical/medical institutions). The matter has been reconsidered in the light of judgement delivered by the Hon'ble Supreme Court of India in the case of Dr. Pradeep Jain Vs. Union of India and others reported as AIR 1984-SC-1421 wherein it was held that instead of the word 'Domicile' the word 'Residence' be used in the instructions issued by the State Governments on the subject. Accordingly, it has been decided by the Government to

revise the Government instructions referred to above as under :-

Sir/Madam,

I am directed to invite your attention to the Punjab Government Circular Letter No. 1/3/95-3PPII/2043, dated 29.1.1996 vide which the instructions were issued regarding simplification of procedure for obtaining the certificate of Domicile for the purpose of admission to educational institutions (including technical/Medical institutions). The matter has been reconsidered in the light of judgment delivered by the Hon'ble Supreme Court of India in the case of **Dr. Pardeep Jain Vs. Union of India and others**(reported as AIR 1984-SP-1421) wherein it was held that instead of the word 'Domicile' the word 'Resident' be used in the instructions issued by the State Governments on the subject. Accordingly, it has been decided by the Government to revise the Government instructions referred to above, as under:

**Subject:** Issuance of Certificates for the purpose of seeking admission to various educational/technical/professional institutions in the State and also for employment.

Sir,

It has been brought to the notice of Government that educational authorities and institutions prescribe various certificates regarding residence, SC/BC category and backward area etc. to be furnished by the students/candidates with the application forms for entrance examination or employment in the formats and by the authorities different from those prescribed by the government departments. Cases have also been reported where the authorities concerned insist on retaining original certificates and refuse to accept the attested photo copies of the certificates. All this results in harassment and panic among the students/candidates and their parents/guardian, since they have to apply with such certificates to more than one authorities simultaneously and within a limited period. The list of certificates required at the time of applying for CET/JET/PMT and PSU are enclosed by way of illustration.

2. In order to overcome the difficulty mentioned above, it has been decided by the Government that the following procedure shall be followed meticulously by all the educational and other authorities concerned:

- (1) Certificates issued in the format and by the authorities prescribed by Government Departments shall be accepted as valid by all educational institutions and other authorities.
- (2) Where a number of authorities have been authorised to issue the certificates there shall be no insistence on issue of a certificate by any particular authority or by the highest authority indicated in the format.
- (3) (a) In case of entrance examinations, no certificate should be called for in the first instance alongwith the application form. It will be sufficient for the candidates seeking admission or

other facility to indicate in the application form whether he/she belongs to any particular category entitling him/her to certain concessions or facility. Requisite certificates may be obtained only from the selected/wait listed candidates.

- (b) To further simplify the procedure attested copies of the certificates only shall be retained and original certificates if required to be produced at the time of interview shall be returned immediately, thereafter.
- 4. Parents/guardian or candidates can also obtain Scheduled Caste Certificate for the purpose of seeking admission as per proforma given below from the Head of Institution where the candidate has studied if the proof i.e. an attested copy of Scheduled Caste Certificate issued by a competent authority in favour of the candidate or the father of the candidate is available in the school records.
- 5.
  - (i) If parents/guardians are employed with Punjab Govt. they can obtain S.C. Certificate from the Head of Dept. or the Head of Office in the proforma given below provided relevant S.C. Certificate exists on the in service record.
  - (ii) If the residents of Punjab who are employed in Govt. of India or any other State Govt. the S.C. Certificate in such cases will also issued by the respective H.O.D. or Head of Office in the proforma given below provided S.C. Certificate exists in their service record.
- 6. In case of freedom fighters; political sufferers, terrorists/riot victims and migrants where the registers are maintained by D.C. Office the certificate may be issued by Deputy Commissioner/ G.A. to D.C./A.D.C.

### ਅੰਤਿਕਾ-1

#### **Section 177. Furnishing false information**

Whoever, being legally bound to furnish information on any subject to any public servant, as such, furnishes, as true, information on the subject which he knows or has reason to believe to be false, shall be punished with simple imprisonment for a term which may extend to six months, or with fine which may extend to one thousand rupees, or with both.

Or, if the information which he is legally bound to give respects the commission of an offence, or is required for the purpose of preventing the commission of an offence, or in order to the apprehension of an offender, with imprisonment of either description for a term which may extend to two years, or with fine, or with both.

#### **Section 193. Punishment for false evidence**

Whoever intentionally gives false evidence in any stage of a judicial proceeding, or fabricates false evidence for the purpose of being used in any stage of a judicial proceeding, shall be punished with imprisonment of either description for a term which may extend to seven years and shall also be liable to fine;

and whoever intentionally gives or fabricates false evidence in any other case, shall be punished with imprisonment of either description or a term which may extend in three years, and shall also be liable to fine.

#### **Section 197. Issuing or signing false certificate**

Whoever issues or signs any certificate required by law to be given or signed, or relating to any fact of which such certificate is by law admissible in evidence, knowing or believing that such certificate is false in any material point, shall be punished in the same manner as if he gave false evidence.

#### **Section 198. Using as true a certificate known to be false**

Whoever corruptly uses or attempts to use any such certificate as a true certificate, knowing the same to be false in any material point, shall be punished in the same manner as if he gave false evidence.

#### **Section 299. False statement made in declaration which is by law receivable as evidence**

Whoever, in any declaration made or subscribes by him, which declaration any Court of Justice, or any public servant or other person, is bound or authorized by law to receive as evidence of any fact, makes any statement which is false and which he either knows or believes to be false or does not believe to be true. Touching any material to the object for which the declaration is made or used, shall be punished in the same manner as if he gave false evidence.
